REQUIRED eligibility to enter the Finals (Saturday/Sunday) - All Open and Youth individuals must have purchased a 2024 NE-4D membership and competed in at least one (1) NE-4D approved event prior to October 1, 2024. A Pee Wee must have a 2024 NE-4D membership, however, is not required to have competed in a NE-4D approved Pee Wee event prior to October 1, 2024.

Youth - must be 13 and under as of January 1, 2024 and have purchased a 2024 NE-4D Youth membership and competed in at least one (1) NE-4D approved Youth event prior to October 1, 2024 in order to compete at the 2024 NE-4D Finals in the Youth class. A youth may compete in the Open class if they have a 2024 NE-4D Open membership. Competing in both the Youth and Open requires both a Youth and an Open membership.

Pee Wee - is Age 7 and under as of the time of the 2024 NE-4D Finals. An individual meeting this age requirement may compete in either the Pee Wee or Youth class at the Finals, but not both. If an individual chooses to compete in the Youth class they are required to have purchased a 2024 NE-4D membership and have competed in at least one (1) NE-4D approved Youth class prior to October 1, 2024.

FRIDAY NIGHT WARM UP RACE: 7:00 p.m. - \$1000 added to Open - NE-4D and BBR Approved ** \$100 added to Youth. Youth rolling to Open MUST check Youth/Open R/O box below. LATE ENTRY: CASH plus \$5 per rider - run after pre-entries. NE-4D/BBR approved. * Membership not required to compete in the Friday Warm-Up Race.
